TERMS AND CONDITIONS

A. Schedule to Conditions of Entry

1. <u>Organiser:</u>	Nestlé Products Sdn. Bhd. [197901000966] ["the Organiser"].

3. <u>Promotion Period:</u>	The Promotion starts at 00:00:00 on 01/03/2022 and closes at 23:59:59 on 30/06/2022.
4. <u>Eligibility:</u>	<p>a. The Promotion is strictly for legal residents of Malaysia aged 18 years and above and with a valid identification document and residential address in Malaysia. 1. Introduction
