

### **TERMS AND CONDITIONS**

## A. Schedule to Conditions of Entry

1.	Organiser:	Nestlé Products Sdn. Bhd. [197901000966] ["the Organiser"].
2.	Promotion:	PROMOSI LACTOGROW BELI & TEBUS EKSKLUSIF DI LOTUS'S ["Promotion"].
3.	Promotion Period:	The Promotion starts at 00:00:00 on 28/07/2022 and closes at 23:59:59 on 26/09/2022.
4.	Eligibility:	The Promotion is open to all individual legal residents of Peninsular Malaysia aged 18 years and above as at the start of the Promotion Period, and with a valid identification document and residential address in Peninsular Malaysia. The Organiser shall reserve the right to request for evidence of identification documents.
5.	Participating Products:	The participating LACTOGROW products are as per listed below ["Products"]:  a. LACTOGROW 3 [1.3kg]; and  b. LACTOGROW 4 [1.3kg].
